Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what wedo.		
What?	<ul> <li>The types of personal information we collect and share depend on the product or service you havewith us. This information can include:</li> <li>Social Security number and transaction or loss history</li> <li>Account balances and payment history</li> <li>Credit history and credit scores</li> </ul>		
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons WeStreet Federal Credit Union chooses to share; and whether you can limitthis sharing.

What We Do		
How does WeStreet Federal Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
How does WeStreet Federal Credit Union collect my personal information?	<ul> <li>We collect your personal information, for example, when you</li> <li>Open an account</li> <li>Make deposits or withdrawals from your account or pay your bills</li> <li>We also collect your personal information from others, such as credit bureaus, or other companies.</li> </ul>	
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>Sharing for affiliates' everyday business purposes - information about your creditworthiness</li> <li>Affiliates from using your information to market to you</li> <li>Sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>	
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.	
Definitions		
Affiliates	<ul> <li>Companies related by common ownership or control. They can be financial and non-financial companies.</li> <li>Our affiliates include companies with WeStreet in the name and financial companies such as Members Insurance Agency doing business as WeStreet Insurance Services</li> </ul>	
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and non-financial companies.</li> <li>WeStreet Federal Credit Union does not share with nonaffiliated third parties so they can market to you.</li> </ul>	
Joint Marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partners maintain the same privacy standards as WeStreet Federal Credit Union.</li> </ul>
