### Terms & Conditions

**How To Earn tickets:** The Contest's begin date will be 8:00 a.m. CST on **November 7, 2025**. The Contest's end date will be 11:59 pm CST on **12/14/2025**. **Kendall Whittier Main Street** will be the official timekeeper of the Contest.

Contest entry is achieved by only the following:

- One ticket is earned for every \$10 in purchases from a participating business.
- A maximum of 20 tickets will be given for any single purchase.
- Purchase is not necessary. Customers may receive one free ticket for a visit to any participating merchant. Limit one ticket per household per day.

**Sponsor:**

Shop & Stroll in Kendall Whittier (contest) is a Kendall Whittier Main Street (KWMS) event sponsored by WeStreet Credit Union (Sponsor). Kendall Whittier Main Street is responsible for all decisions of the event regarding the selection of winners and all other aspects of the Contest shall be final and binding in all respects. The Sponsor will not be responsible for typographical, printing, or other inadvertent errors in these Official Rules or in other materials or announcements relating to the Contest.

**Eligibility.** Subject to the following restrictions, this Contest is open to residents of the state of Oklahoma who are 18 years or older at the time of entry and who accurately follow the entry rules. Employees and volunteers of WeStreet Credit Union and its affiliates and their immediate family members residing in a single household are not eligible. Entry into this Contest or acceptance of any prize constitutes acceptance of the Official Rules.

Business owners, managers, employees, and immediate family residing in the household of that particular business are not eligible to win on tickets from that business' ticket roll number but are eligible to win on tickets from other businesses. Businesses may not exchange tickets with other businesses!

Kendall Whittier Main Street employees, board members, and their immediate families residing within the same household are not eligible to win. Purchase is not necessary. Customers may receive one free ticket for a visit to any participating merchant. Limit one ticket per household per day. Tickets must not be wrinkled, crumpled, torn, or written on, or they will not be accepted.

Winners are required to sign a release waiver and will be responsible for all applicable taxes.

**Winner Selection and Odds.** Kendall Whittier Main Street admin will select three prize winners in a random drawing from among all eligible entries received during the Contest period. Odds of winning depend on the number of eligible entries received. The number of entries is dependent upon the amount purchased from participating Kendall Whittier businesses. All entries become the property of the Sponsor and will not be returned.

Any unclaimed prize monies will be used by Kendall Whittier Main Street toward the community's identified need.
